Your Program Requirements

This program guide defines the 20.0 credits required for the Bachelor of Fine Arts (BFA) in Sculpture/Installation, including Major requirements (specific courses and course options), Arts & Science requirements and open electives.

Of the 20.0 credits required, the following applies:

- No more than 6.0 credits may be at the 1000 level
- At least 5.0 credits must be at the 3000 level or higher, including at least 1.0 credit at the 4000 level or higher
- At least 1.5 credits of Arts & Science courses must be at the 3000 or 4000 level

Reading Your Program Guide

Course Codes

Codes begin with a four letter subject code followed by four digits. The first digit indicates the year level of the course. For example, *GRPH-2004* designates a specific *Graphic Design* course at the *2000 level*. Generally, students complete 1000 and 2000 level courses before 3000 and 4000 level courses.

Course Weight

- 0.5 credit courses typically meet three hours per week for a 12-week term.
- 1.0 credit courses typically meet six hours per week for a 12-week term.

Major Requirements - Course Options

Although a specific number of credits are required from each category, you may choose to take additional courses from these lists as open electives.

Sample 4 Year Plan & Helpful Planning Information (at the end of this package)

The program is structured so that it can be completed in four years, by a student taking 2.5 credits per term in the fall and winter terms (a limited number of courses are also offered in the spring/summer terms). The sample plan will help you plan your courses.

In addition to general planning tips and suggested pathways, the helpful planning information can include recommended courses for your program and tips on meeting prerequisites for electives you may want to take.

Senior undergraduate students in good academic standing may take graduate courses at the **5000 level** from any of the following subject areas: CADN, CRCP, DHEA, DIGF, INCD, SFIN. Inquiries regarding access to 5000 level courses should be directed to the student's Faculty Office.

Students who have completed a minimum of 4.0 credits and are in good academic standing may **declare a minor**. Only open electives and general Arts & Science courses may fulfill both degree and minor requirements, subject to the credit limits stipulated in this program guide. ^{*} Visual culture courses (IVCV, VISA, VISC, VISD, VISM) taken to fulfill Major requirements may also fulfill Arts & Science requirements. In this case, replace the credit value in this section with an open elective(s).

Helpful Planning Information – Sculpture/Installation

General Planning Tips:

When planning your courses, keep in mind that the **Specific Courses** (required) focus on core concepts in Sculpture and Installation that support interdisciplinarity, which is foundational to Sculpture/Installation. **Course Options** support further advanced technical and critical learning opportunities for deeper investigation within SCIN which allow you the flexibility to direct your studies.

Planning Considerations - Option Category A & Option Category B:

• Although you are only required to take one of the 2000 level introductory courses in Option Category A (CROS/SCIN) and another in Option Category B (FABR/SCIN/INVC), it will be advantageous to take more of them, depending on your research, material approaches and critical inquiry.

Planning Considerations - Option Category D:

The requirements in **Option Category D** for professional experience offer a range of options, allowing you to gain professional knowledge. Such experience can provide a significant head start into future opportunities.

- A Field Placement (SCIN-4897) provides an opportunity for hands-on experience in an area of interest with a gallery, research lab, artist studio, or other related field. With the assistance of the Centre for Emerging Artists and Designers you can research and identify options. You may take up to 1.5 credits of field study over years 3 and 4.
- The courses CROS-3023 Learning in the Field I and CROS-3024 Learning in the Field II (both courses must be taken in the same academic year) provide more support and structure, but also places you in the field as an intern in the same way as a Field Placement.
- The CROS-3001 Professional Practice course provides a comprehensive survey of the practicalities, approaches, and opportunities in pursuing an art career across a number of disciplines.
- A combination of courses in this category can greatly supplement your course learning.

Planning Considerations – Open Electives:

- Exploration is encouraged to support your practical and critical skills across different program areas.
- When choosing Open Electives, we recommend you consider the courses in the Option Categories (Categories A through F) as these courses are a good fit with your major.
- If you take more courses than the minimum requirement to fulfill the Category, these courses will fulfill Open Electives.

Planning for Fourth/Final Year:

- Students need a minimum of 1.0 credit at the 4000 level. You can choose to fulfill this by completing SCIN Thesis, CROS Thesis, or advanced SCIN/FABR courses in Category F, or other 4000 level elective courses within the university. If you don't meet this requirement in completing Option Category F, then ensure you meet this requirement when completing Option Category D, Arts & Science electives (in Categories J, K, or L) or Open Electives.
- SCIN and CROS Thesis are offered across two terms at the 4000 level. Thesis is a focused studio experience that will allow you to concentrate on a major portfolio of work and complement your professional practice skills. Thesis builds on your past work and identifies and supports your future goals such as future exhibition opportunities, graduate school applications, professional artistic practice.
 - If you choose to take Thesis, CROS or SCIN, it is recommended that you take both the fall and winter term courses as it provides a concentrated fourth year experience with your peers and allows you focus on your final body of work.
 - In the case of SCIN-4901 SCIN Thesis: Research and SCIN-4902 SCIN Thesis: Presentation, either or both courses may be taken. Refer to the course descriptions in the Course Catalogue for the pre-requisites for these courses.
 - CROS-4901 Open Studio Thesis: Research and CROS-4902 Open Studio Thesis: Presentation are also an option to complete this category. Refer to the course description for CROS-4901 in the Course Catalogue for the prerequisites. CROS-4901 is the pre-requisite for CROS-4902.
- You have flexibility as to when you take Thesis: Research (Fall) and Thesis: Presentation (Winter) in Category F and/or Open Electives. Thesis courses from other programs are an option and may have different guidelines.

Planning for Specific Pathways:

- When selecting courses in programs outside of SCIN, be mindful of pre-requisites for 3000 and 4000 level courses. Ensure that you review the course description and pre-requisites for all courses so you can plan correctly from year to year.
- If you are intending to pursue a master's program or other field of study after OCAD U, plan to take the Thesis Courses in Option Category F (either CROS-4901 and CROS-4902, or SCIN-4901 and SCIN-4902).
- Art and Public Spaces Minor: This cross-disciplinary minor in Sculpture/Installation focuses on issues of art in public space. Minors give students the opportunity to pursue a secondary field of study without compromising their major field. "Minors" refers to a defined and sequenced selection of 3.0 to 5.0 full credits in a specific discipline or in interdisciplinary subjects. Minor courses may fulfill Open Electives and general Arts & Science electives for the degree.
