Part 1: Synthesis of Review Documents:

a) Summary of Cyclical Program Review:

This is the first institutional review of the Criticism and Curatorial Practice program since the UPRAC in 2009, and follows the new Institutional Quality Assurance Process implemented in 2011. The program review team was led by the CRCP program chair and included a small team of faculty teaching in the program.

The process involved extensive input from faculty, students and staff through information gathering activities such as mapping the program learning outcomes and course learning outcomes against the OCAD U Degree-Level Expectations; a detailed curriculum mapping exercise; SWOC analysis; student and faculty surveys; and student focus groups augmented by the collection and analysis of program-related data provided by the Office for Institutional Analysis.

The information collected in these activities culminated in the self-study brief document written over the course of the 2015/2016 academic year.

External reviewers received the self-study brief, and came to campus for an intensive two-day site visit February 6 and 7, 2017. They met with the program review team, faculty teaching in the program and students from all year levels. They also had classroom visits, met with the Gallery Systems staff and Library staff, as well as the Dean, Faculty of Art and the Vice-President, Academic and Provost. They completed their report on March 15, 2017.

Summary of external reviewer report:

Overall the external reviewer report was very positive, confirming that the CRCP program is consistent with OCAD U's mission and academic plan and well-positioned to continue offering an outstanding education. As well, the program's learning outcomes and requirements are clear and appropriate. Key issues and areas identified in the report were:

- Program-specific recruitment to enhance enrolment growth
- Augmentation of the curriculum with new course development and experiential learning opportunities for students.
- Support of the Program and development of its capacities with new faculty appointments
- Increased avenues for the Program and the OCADU Galleries System to develop both curricular and co-curricular offerings

Overview of internal response:

In light of the new Academic Plan (which had not been ratified at the time of the external review) the Dean and Chair have identified a number of areas to move forward on, several of which are already underway:

- The CRCP Chair now sits on the Admissions, Recruitment and Retention Committee and will work with the Admissions Office to develop Program specific recruitment strategies.
- The program committee is working to develop new curriculum to address the expansion of the curatorial field across multiple platforms.
- Giving priority to the Indigenous Hiring Plan to be implemented in 2017-18, a proposal for a dedicated faculty hire in CRCP will be brought forward in 2018-19.

Part 2: Strengths, Challenges, and Recommendations:

a) Strengths and Challenges:

Strengths

- The CRCP program is consistent with OCAD U's mission and academic plan and it is well-positioned to continue offering outstanding education to future generations of curators, artists and cultural practitioners.
- The CRCP program reflects a great deal of pedagogical innovation and creativity, and the objectives of the Program place interdisciplinarity, diversity and sustainability as priorities.

- CRCP faculty bring an incredibly diverse and varied research and practice-based expertise into the classroom. The quality of the faculty is also reflected in their exceptional professional outputs, including a number of teaching awards and nominations.
- The program is successful in drawing on the offerings of the University as a whole (studio courses, theory, art history, Indigenous studies, and art and social change). The program learning outcomes are clear, appropriate and in keeping with OCAD U University Degree-Level Expectations.
- The diversity of interests manifested by students—from critical writing to curatorial engagement in diverse areas of research—are evidence of the capacity of the program to foster individual interest and development.
- The Program's status as a unique undergraduate degree program, with no parallels, is a noteworthy asset for students desiring to move on to Graduate Studies in the field.

Challenges

- Lack of visibility in terms of showcasing the success stories of faculty, students and alumni on the website and in promotional materials.
- Increasing student enrolment in the absence of a strategic enrolment/recruitment strategy
- A lack of Program dedicated faculty, with ongoing dependence on cross-appointed, sessional and CLTA faculty.
- Scheduling and infrastructural coordination of curriculum, especially in relation to the Faculty of Liberal Arts & Sciences and School of Interdisciplinary Studies (FoLASSIS).
- The lack of CRCP curatorial lab space and spaces for thesis exhibitions.
- Integrating student placements and coordinating curricular and co-curricular activities in relation to the OCAD U Gallery System.

b) Recommendations: .

1. Grow and strengthen the program by bolstering student enrolment management and recruitment in conjunction with the Admissions Office. Increase the public profile through promotional materials that clearly articulate the unique aspects of this undergraduate program within the broader educational landscape of North America.
2. Stabilize and renew the faculty complement.
3. Enhance the relationship between CRCP program and the OCAD U Galleries System, in particular in the area of professional skill development, research opportunities, and high impact practices within an A-level museum environment; and develop opportunities for experiential learning and student thesis projects (research and presentation).
4. Continue to expand and strengthen the curriculum in particular through the integration of Indigenous knowledges and content, new curatorial platforms, and media arts criticism and curation.
5. Increase communication platforms for students across the degrees to foster mentoring and peer relations among students, and strengthen faculty-student exchange; hold regular (formal or informal) gatherings to discuss the program and its opportunities in order to create a more close-knit community;

6. Enhance common work-study and exhibition spaces in conjunction with the Creative City Campus.
7. Develop a minor in CRCP to enable all students to apply the knowledge of professional curatorial processes to their work and the development of their careers as practicing artists, designers and those aiming for a job in cultural industries
8. Enhance exhibition initiatives and programs within the Gallery System, to heighten the progressive and unique role that CRCP plays in the city's arts ecology and beyond.
9. Review the proposed international guest curator program for a clarified relation to the undergraduate CRCP Program.
