Executive Summary of Cyclical Program Review

The final stages of this review, including this Executive Summary, were led by Paulette Phillips, Chair of Sculpture/Installation (SCIN), Integrated Media (INTM) and Life Studies (starting in Fall 2022). The initial cyclical program review process was conducted between September 2019 and June 2020 and was led by former chair Claire Brunet, with Barbara Rauch, Luke Parnell, Nina Leo, Claire Brunet, Francis LeBouthillier and Derek Sullivan. The external site visit was overseen by interim chair Natalie Waldburger, and the internal response process was led by acting chair Jason Baerg. The review process was done in parallel with the Flow curriculum transformation process. Faculty and student consultation was robust, and the Flow revisions and the IQAP process itself both provided opportunities for input from a broad range of stakeholders and levels of governance.

The cyclical program review outlined all current aspects of the program. The reviewers found the SCIN program to be of high quality, meeting the current needs of the discipline and providing innovative opportunities to students such as its exhibition program and public art projects. The reviewers found the program to be consistent with the institution's mission and academic plan, particularly in areas of decolonization, interdisciplinarity and experiential learning. The program requirements and learning outcomes were found to be appropriate and in

alignment with the Degree-Learning-Expectations. However currently SCIN does not have any permanent IBPoC faculty attached to their curriculum.

Student surveys and discussions indicated that there is a high degree of satisfaction with the teaching and support of faculty, and that the areas of concern included the need for: additional space in which to create and store their work; better access to elective courses particularly in Fabrication; additional professional practice instruction; and more digital technology infrastructure.

Program retention of students is strong throughout the years but there has been a significant decline in registrants in the program and an increase in students opting to take part-time studies.
